STATEMENT OF PRACTICAL TREATMENT:

IN CASE OF CONTACT WITH EYES. Immediately flush eyes with plenty of water for at least 15 minutes. Call a physician.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth to mouth. If breathing is difficult, give oxygen. Call a physician.

IF SWALLOWED: DO NOT INDUCE VOMITING. Never give anything by mouth to an unconscious person. Call a physician or Poison Control Center immediately.

IN CASE OF SPILL: Remove all sources of ignition. Contain spill and absorb with earth, sand or vermiculite. Sweep into closed container for disposal according to local, state and federal regulations. Do not flush to sewer.

IN CASE OF FIRE: Use CO², dry chemical, foam or water spray. Cool with water, containers exposed to heat or flame.

STORAGE & HANDLING: Keep containers closed and upright to prevent leakage. Store in cool, dry well ventilated area. Carefully remove closure to release possible internal pressure in container. Use spark resistant tools and ground container before transfer of product.

HANDLING OF EMPTY CONTAINER: Observe all label precautions even after container appears empty because residue may remain. Therefore, do not cut, drill, grind or weld on or near this container. Do not reuse container unless thoroughly cleaned.
